

ENVIRONMENTAL POLICY

Medical Products Research is committed to implementing targeted actions which aim to protect the environment and develop the principles of sustainability. The present Environmental Policy formalizes this purpose.

Following in-depth analysis into the environmental impacts that may derive from activities managed directly or indirectly by its own organization present and operating at the Legnano site, the Organization has implemented an Environmental Management System in compliance with the standard ISO 14001. Said standard does not only guarantee compliance with legislation and environmental requirements, but it also enables the Organization to achieve a continuous improvement to the environmental performance of its own activities, products and services, within their entire life cycle, and to eliminate or mitigate risks to the environment.

The Organization has identified key opportunities for action and therefore the management of Medical Products Research resolves to:

- Maintain an Environmental Management System active in compliance with the UNI EN ISO 14001 standard, suitable for the nature, size and environmental impacts of its own activities, products and services.
- Comply with laws and environmental requirements applicable to its own activities, products and services.
- Introduce and actively maintain a clean electric energy production system, through the use of a photovoltaic system renewed in 2023.
- Control the consumption of water, reduce energy consumption, minimize the use of consumables and improve logistical efficiency.
- Encourage accountability and awareness among all employees as regards environmental protection, by promoting training and awareness-raising activities among its staff regarding environmental and sustainability issues.
- Improve aspects pertaining to personnel mobility. In this regard, the use of telecommunications systems with customers and suppliers is encouraged, avoiding physical travel as much as possible, consistently with the work to be done. Where necessary, arrange for the use of hybrid cars and group travel.
- Disclose this Environmental Policy to all people who work for or on behalf of the Organization, while also making it available to the public.
- Ensure cooperation with all the interested parties.
- Gain knowledge of and promote its own suppliers' environmental management system.
- Correctly manage the waste produced, with particular attention to separable and special waste.
- Adopt suitable intervention measures for preventing and minimizing emergency situations.
- Supply customers and consumers with all necessary information on the environmental impact of commercialized products.
- Promote the design and development of products with high eco-compatibility characteristics, in terms of energy efficiency.
- Promote and guarantee the correct disposal of end-of-life products through a proper awareness campaign addressed to Medical Products Research distributors and through the information provided in the User Manual for the direct users of the products.
